It was a lovely evening full of engaging and inspiring stories and dialogue. Our News 18 Bullying special aired. We received a lot of positive feedback from the local schools in terms of the conversations it generated during the school days. We also received a number of e-mails and letters from students about efforts going on in their schools regarding bullying and anti-bullying efforts. Many of those e-mails and letters are turning into news stories. April 3 was primary election night. We had a live shot from the Republican headquarters in Eau Claire. We also had a live hit with Greg Neumann from Milwaukee where Mitt Romney was camped out. We held our April weather academy on the 12th at the Montessori elementary school in Eau Claire. We lead a tour of the Youth Leadership Eau Claire class for their media day. April 24 was the annual Eau Claire Area Chamber of Commerce annual meeting and banquet. WQOW was a sponsor and provided video production. Several staff members were in attendance. Anchor/reporter Megan Wiebold is participating in the Chippewa Falls "Citizens Fire Academy. It is a hands on training course for the public at large to get a feel for what firefighters do. Training involves all aspects of fire and EMS services. It is a six week course. April 19, WQOW was a sponsor of the Scrabble Bee, which is the largest fundraiser for Literacy Volunteers of the Chippewa Valley. Jerry Gallagher was the emcee. We also had a WQOW team compete at the event. April 26, Lisa Patrow was invited to UW-Eau Claire for a luncheon with various departments including the dept. of Journalism. She ate with students and answered career-related questions. April 26, WQOW was a sponsor of the Western Dairyland Business Conference which targets area women. Seminars are conducted and women are invited to sell their wares. The Eau Claire Marathon was held on Sunday, May 6. WQOW News 18 was a sponsor. Daybreak anchors Amie Winters and Aaron Rhody and producer Trent Artus helped hand out medals to the winners. All proceeds from Sunday's marathon will go to the Eau Claire YMCA. Meteorologist Doug Michaels gave two school weather talks to elementary school students in Rice Lake and Prairie Farm. May 3, WQOW held a News 18 Weather Academy at Manz elementary school in Eau Claire. The event was extremely well attended! Our team of meteorologists did a fantastic job of predicting and tracking a storm that hit Trempealeau county late last week. We sent news crews to the scene thankfully no serious injuries but fairly significant damage. Bob Bradovich was the emcee at the Special Olympics track and field competition in Eau Claire on Saturday, May 5. He's been the emcee for the event for more than ten years. WQOW was honored to be a part of the Freedom Honor Flight to Washington, D.C., on May 12. Trent Artus and Kyle Jorgenson were able to represent us and came back with four stories that we promoted for sweeps. Lisa Patrow has been interviewed for a cover story in a local magazine called Wisconsin West. The issue will come out July 1. On Thursday and Friday, May 17-18, Meteorologists Nick Grunseth, Doug Michaels and LeAnn Lombardo represented WQOW News 18 at Special Kids Day at Lake Wissota, an annual event that provides fun and entertainment to area youth with cognitive disabilities. They danced with the children and let the "Rockin' Robin" dance contest. They handed out prizes and soda during the event too. In total, approximately 200 children plus adults and volunteers were present.
