During the past quarter, we aired "Houston Symphony: 100 Years of Music" (D1, Sunday, June 16th at 10:35 PM) which explored the rich history of the Houston Symphony and their tremendous involvement and importance to our community. We also aired live the Houston Symphony's 100th Birthday Concert (Friday, June 21st at 8:30 PM) which celebrated the symphony's 100th year of world class performances. Each Sunday from 11:00 am to 12:00 PM we also air programs that celebrate the rich diversity of Houston and highlight issues, trends, and important people within our various communities. These programs are Crossroads (focusing on our African American community), Viva Houston (focusing on our Latino community), and Visions (focusing on our Asian American community). We air on average 18 to 25 PSA's per week in various dayparts on our 13.1, 13.2 and 13.3 stations specifically beneficial to children.
