Q13 Fox First Forecast Channel (powered by AccuWeather) is carried on digital channel 13.2. Different episodes of DRAGONFLY TV and SWAP TV aired on the secondary channel 13.2 than aired each week on KCPQ's primary channel 13.1. KCPQ's secondary channel 13.2 experienced technical difficulties during Edgemont's 3/3/12, 2p broadcast; only the first 15min aired (net encoder malfunctioned-unknown reason-and program was unrecoverable immediately). This Edgemont episode aired again in full when next possible, at 3:00p same day (we were unable to publicize this change in advance). The distributor cancelled syndication for the program Ariel & Zoey & Eli Too after its 2/2/12 telecast. Therefore, we replaced it with an additional run of Edgemont on Thursdays effective 2/9/12.
