The episode was rescheduled in its second home on 3/9/13 and promotional efforts were made to notify the public of the rescheduled date and time. We did not count the episode that aired with no audio into our weekly average. On Saturday 3/23/13 a recording error overnight Friday caused Doodlebops II, Busytown Mysteries I and Busytown Mysteries II to air out of sequence and two scheduled programs, Liberty Kids I and II, to not air. An extra run of Busytown Mysteries I and Doodlebops I aired but we did not include this in our weekly average. We were unable to notify the public of these changes because they took place at the last minute due to technical problems. Liberty Kids I and Liberty Kids II were rescheduled for 3/30/13 and promotional efforts were made to notify the public of the change. Some preempted children's programming was not rescheduled in its second home due to technical problems and due to extensive CBS Sports coverage during the NCAA basketball tournament. After due review of internal station records and documentation provided to us by program suppliers, the licensee hereby certifies as follows: (i) the only programs specifically designed for children ages twelve and under that the station broadcast this quarter are disclosed in this report and (ii) the licensee fully complied with the FCC's commercial limits in children's programs, as specified at 47 C.F.R.
