On Saturday 12/7 at 6:00pm on D1, we aired "Heart and Soul," a half-hour, locally-produced series that captures the essence of the African American culture as it relates to the great city of Chicago. The show was rebroadcast on Saturday, 12 /21 at 2:00pm on D1.
