Special operating conditions or restrictions:

The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

- 2 Permittee/Licensee shall accept such interference as may be imposed by other existing 250 watt Class C stations in the event that they are subsequently authorized to increase power to 1000 watts.
- Ground system: 120 equally spaced 128 meters long (420 feet) buried copper ground radials equally spaced around the base of the tower along with a 15 meter round ground screen about the base of the drop wire antenna used for KPHX approximately 228 meters from the KSUN/KQFN tower.
