If the licensee makes any changes in the facilities via a modification of license application in accordance with 47 C.F.R. Section 73.1690(c), the subsequent FCC Form 302-FM, application for license, must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines.

- 3 Grant of this license application is conditioned on the continuous operation of the licensed facility for the twelve-month period following grant. The failure of the facility to so operate will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(c) unless the licensee rebuts the presumption that the authorized facilities were temporarily constructed.
