Special operating conditions or restrictions:

Grant of this license application is conditioned on the continuous operation of the licensed facility for the twelve-month period following grant. The failure of the facility to so operate will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(e) unless the licensee rebuts presumption that the authorized facilities were temporarily constructed.

Special operating conditions or restrictions:

- The permittee/licensee, in coordination with other users of the site, must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of the FCC guidelines.
- Warning signs which describe the radiofrequency electromagnetic field hazard must be posted at appropriate intervals. Access to the site must be restricted to prevent the exposure of humans to RF emissions in excess of the FCC guidelines (OET Bulletin 65, Edition 97-01, released August 1997).
- The licensee has demonstrated compliance with the FCC radiofrequency electromagnetic field exposure guidelines based on the use of the antenna specified herein. If the licensee makes any changes in the facilities via a modification of license application in accordance with 47 C.F.R. Section 73.1690(c), the subsequent FCC Form 302-FM, application for license, must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines.
