Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

- 1 Under the rules adopted in MM Docket 88-375, the permittee may commence program tests with the facilities authorized herein with an effective radiated power in excess of that authorized up to a maximum of 6.0 kilowatts PROVIDED: all conditions specified in the Commission's Public Notice of November 3, 1989 (Ref. No. 451) are met. These include no change in HAAT, compliance with ANSI RF radiation limit per FCC OST Bulletin No. 65, no violation of multiple ownership restrictions per Section 73.3555, filing of FCC Form 302 with supplemental exhibit (attached to Public Notice) and appropriate filing fee within 10 days of program tests.
