- 1 Licensee shall be responsible for satisfying all reasonable complaints of blanketing interference within the 1 V/m contour as required by Section 73.88 of the Commission's rules.
- 2 Ground system consists of 120 equally spaced, buried, copper radials about the base of the tower, each 36.6 meters in length except where terminated by property boundaries.
- 3 The antenna shall be excited with a symmetrical folded unipole feed, utilizing a minimum of three folds. Slant wire is not permitted.
