Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

  - 1) The applicant, Point Five, LLC, will operate the Barstow, California, station independently from stations owned by The Drive, LLC and from any Station in the Victor Valley Market not owned by principals of Point Five, LLC;
  - 2) The Barstow station will not share studio or office space, or a mailing address, with any station licensed to The Drive, LLC, or KHWY, Inc., or any subsidiaries thereof; and
  - 3) The Barstow station will not share employees or management personnel with any station licensed to The Drive, LLC or KHWY, Inc. or any subsidiaries thereof.
