- 3 In addition, neither radiation component shall increase at a rate exceeding 0.2 dB per degree from the azimuths of restricted radiation specified above nor exceed a maximum-to-minimum ratio of 15 dB. The rms of the vertically polarized radiation pattern shall not exceed that of the horizontally polarized radiation pattern.
- 4 THE LICENSEE SHALL RESOLVE ALL INTERMEDIATE FREQUENCY INTERFERENCE COMPLAINTS IN THE AREA WHERE THE 20 MV/M CONTOUR OF ITS PROPOSED OPERATION WILL OVERLAP THE 20 MV/M CONTOUR OF STATION WRBS(FM), BALTIMORE, MARYLAND.

THE LICENSEE WAIVES THE RIGHT TO A HEARING IF THE COMMISSION DEEMS IT NECESSARY TO REDUCE POWER TO AVOID SERIOUS INTERMEDIATE FREQUENCY INTERFERENCE PROBLEMS IN THE AREA WHERE THE 20 MV/M CONTOUR OF STATION WQSR(FM) OVERLAPS THE 20 MV/M CONTOUR OF STATION WRBS(FM).
