1 MONITOR POINT DESCRIPTIONS

- $260\,^\circ$ From intersection of Malverne Avenue and Carrolton Place, proceed left on Carrolton to middle of block, 5.15 km from site, max 10.5 mV/m daytime.
- $280\,^\circ$ Point located on southeast corner of Buxton Avenue and Alan Place, ten feet south of street sign and stop sign, 4.83 km from site, max 16.5 mV/m daytime.
- $304\,^\circ$ From intersection of Hempstead Turnpike and Cherry Valley Road, proceed right onto Cherry Valley 0.48 km to entrance of Garden City rubbish disposal, then left on service road around municipal garage building, then right at incinerator smoke stack and proceed 61 meters to center of field (midway between house and incinerator), 4.59 km from site, max 20.6 mV/m daytime.
