Notwithstanding the grant of this construction permit or the expiration date specified herein, your station's license will automatically expire as a matter of law on March 3, 2013 if the station has not resumed broadcasting before that time. See Pub. Law No. 104-104, 110 Stat. 56, Section 403(1) (1996) and Order, Silent Station Authorizations, FCC 96-218 (released May 17, 1996).
