Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

THESE MEASUREMENTS SHALL BE SUBMITTED TO THE COMMISSION ALONG WITH THE FORM 302 APPLICATION FOR LICENSE.
