These include no change in HAAT, compliance with the ANSI RF Radiation Limit per FCC OST Bulletin No. 65, No violation of the Multiple Ownership Provisions of 47 CFR Section 73.3555, and the filing of FCC form 302 with the supplemental exhibit(Attached to the Public Notice) and appropriate filing fee within 10 days of commencing program tests.
