> Re: Request for Modification and Waiver of Phase Assignment WBGT-CD, Rochester, NY Facility ID No. 10318 LMS File No. 0000078677

Dear Licensee,

On July 26, 2019, Stellar Television, LLC (Stellar), the licensee of WBGT-CD, Rochester, New York (WBGT-CD or Station), filed a *Request for Modification and Waiver of Phase Assignment* requesting to modify the post-incentive auction transition phase assigned to the station in the *Closing and Channel Reassignment Public Notice* from Phase 4 to Phase 7.<sup>1</sup> For the reasons below, we grant Stellar's request for waiver and modify the Station's phase assignment to Phase 7, as conditioned herein.

*Background*. Pursuant to the *Transition Scheduling Adoption Public Notice*, individual stations may request waiver and modification of their phase assignment.<sup>2</sup> A waiver is appropriate where the particular facts would make strict compliance inconsistent with the public interest and deviation from the general rule would relieve hardship, promote equity, or produce a more effective implementation of overall policy on an individual basis.<sup>3</sup> The Media Bureau (Bureau) has stated it will evaluate such requests on a case-by-case basis to assess the impact on the transition schedule, including the impact on other broadcasters as well as viewers, in order to facilitate a timely and orderly transition.<sup>4</sup> The Bureau determined that it would view favorably requests that are compliant with the Commission's rules and

have little or no impact on the transition schedule.<sup>5</sup> Requests that the staff determines would be likely to delay or disrupt the transition schedule will be viewed unfavorably.<sup>6</sup>

WBGT-CD is currently licensed to operate on channel 46. The Station was reassigned to channel 29 in the *Closing and Channel Reassignment Public Notice* and assigned to transition Phase 4, which has a phase testing period start date of June 22, 2019, and a phase completion date of August 2, 2019. The Station is located in the Rochester, New York, Designated Market Area (Rochester DMA). A total of five stations were repacked in the Rochester DMA, with four stations, including WBGT-CD, being assigned to transition Phase 4, and one assigned to Phase 10. Stellar states that it was recently informed by its transmitter manufacturer, Rohde & Schwarz, that its transmitter will not be shipped until August 20, 2019.<sup>7</sup> Stellar anticipates that it will be ready to transition early in Phase 7.<sup>8</sup> Stellar states that because the Station is currently operating in the 600 MHz band, this phase change will not create any new linked-station sets or result in increased pairwise interference greater than two percent during the transition period.<sup>9</sup> As a result, Stellar requests that WBGT-CD be moved from Phase 4 to Phase 7, which has a testing period start date of October 19, 2019, and a phase completion date of January 17, 2020.<sup>10</sup> In order to minimize potential viewer confusion caused by the change in phase, Stellar commits to take additional steps beyond what is required by the Commission's rules to notify viewers of its transition through notices on its website.<sup>11</sup>

*Discussion.* Upon review of the facts and circumstances presented, we find that Stellar's request to modify the phase assignment for WBGT-CD to transition to its post-auction channel in Phase 7 satisfies the requirement for a waiver and is in the public interest. We find that the change to the Station's transition phase should not have an adverse impact on the overall transition schedule or a negative impact on other stations or viewers. Staff has confirmed that the phase change will not create any new linked station sets or direct dependencies. Although the total number of rescan periods in the Rochester DMA will increase from two to three, which is one more than the two rescan periods per DMA limitation used in the tool adopted by the Bureau in the *Transition Scheduling Adoption Public Notice* to assign stations to transition phases,<sup>12</sup> Stellar has committed to taking additional steps beyond what is required by Commission consumer education rules to notify viewers of its change in phase. Delays related to manufacturing and delivery of the Station's transition phase will ensure that the Station is able to continue to serve its viewers without interruption. As a result, we find the facts and circumstances discussed above outweigh any viewer burden caused by an additional rescan period in the Rochester DMA or a short delay in access by 600 MHz wireless licensees to the Station's pre-auction channel.

We remind Stellar that pursuant to the Spectrum Act, the Station is eligible for reimbursement from the TV Broadcast Relocation Fund (Fund) of costs "reasonably incurred . . . in order for the licensee to relocate its television service from one channel to the other."<sup>13</sup> Additional expenses incurred, such as expenses resulting from changes in a Station's transition plan that are not related to the post-incentive auction channel change, may not be reimbursable from the Fund.

Accordingly, we **GRANT** Stellar's *Request for Modification and Waiver of Phase Assignment* and modify the transition phase assignment for WBGT-CD **from Phase 4 to Phase 7**, subject to all the commitments made in its waiver request and compliance with all Commission rules applicable to transitioning stations.<sup>14</sup> Testing on the Station's post-auction channel **may not begin until 12:01 am local time on October 19, 2019**, and WBGT-CD is required to cease operating on its pre-auction channel **no later than 11:59 pm local time on January 17, 2020**.<sup>15</sup> The Station's construction permit expiration date will also be modified to correspond to its new phase completion date.<sup>16</sup>
