> Re: Request for Modification and Waiver of Phase Assignment WJMY-CD, Demopolis, AL Facility ID No. 30283 LMS File No. 0000080856

Dear Licensee,

On September 3, 2019, TTI, Inc. (TTI), the licensee of WJMY-CD, Demopolis, Alabama (WJMY-CD or Station), filed a *Request for Modification and Waiver of Phase Assignment* requesting to modify the post-incentive auction transition phase assigned to the Station in the *Closing and Channel Reassignment Public Notice* from Phase 5 to Phase 6.¹ For the reasons below, we grant TTI's request for waiver and modify the Station's phase assignment to Phase 6, as conditioned herein.

Background. Pursuant to the *Transition Scheduling Adoption Public Notice*, individual stations may request waiver and modification of their phase assignment.² A waiver is appropriate where the particular facts would make strict compliance inconsistent with the public interest and deviation from the general rule would relieve hardship, promote equity, or produce a more effective implementation of overall policy on an individual basis.³ The Media Bureau (Bureau) has stated it will evaluate such requests on a case-by-case basis to assess the impact on the transition schedule, including the impact on other broadcasters as well as viewers, in order to facilitate a timely and orderly transition.⁴ The Bureau determined that it would view favorably requests that are compliant with the Commission's rules and

have little or no impact on the transition schedule.⁵ Requests that the staff determines would be likely to delay or disrupt the transition schedule will be viewed unfavorably.⁶

WJMY-CD is currently licensed to operate on channel 25. It was reassigned to channel 17 in the *Closing and Channel Reassignment Public Notice* and is currently assigned to transition Phase 5, which has a phase testing period start date of August 3, 2019, and a phase completion date of September 11, 2019.⁷ The Station is located in the Montgomery, Alabama, Designated Market Area (Montgomery DMA). A total of eight stations were repacked in the Montgomery DMA, with seven stations, including WJMY-CD, currently being assigned to transition Phase 5, and one station assigned to Phase 10. TTI states that it is in the process of building a new tower and delays have prevented it from being completed by the end of Phase 5.⁸ As a result, TTI requests that the Station's transition phase assignment be modified from Phase 5 to Phase 6, which has a testing period start date of September 7, 2019, and a phase completion date of October 18, 2019.⁹ TTI anticipates that its facility will be completed by the end of September 2019. TTI acknowledges that WJMY-CD is part of Linked-Station Set 41 (LSS 41) and is directly linked with WAKA(TV), Selma, AL.¹⁰ In order to prevent increased temporary pairwise interference greater than two percent,¹¹ WJMY-CD has filed for and been granted special temporary authority (STA) to operate at reduced power on its pre-auction channel.¹²

Discussion. Upon review of the facts and circumstances presented, we find that TTI's request to modify the phase assignment for WJMY-CD to transition to its post-auction channel satisfies the requirement for a waiver and is in the public interest. We agree that changing the Station's transition phase to Phase 6 should not have an adverse impact on the overall transition schedule or a negative impact on other stations or viewers. Staff has confirmed that if WJMY-CD operates on its pre-auction channel at the parameters authorized in its STA, the phase change will not create any new linked-station sets or increased temporary pairwise interference above two percent. By moving WJMY-CD to Phase 6, the total number of rescan periods in the Montgomery DMA will increase to more than the two rescan periods per DMA limitation used in the tool adopted by the Bureau in the *Transition Scheduling Adoption Public Notice* to assign stations to transition phases.¹³ To ensure viewers are fully informed about the

repack and minimize any viewer confusion caused by the Station's change in phase and increase in rescan periods, we require that TTI to air, at minimum, double the amount of on-air consumer education notifications required by the Commission's rules in advance of its transition.¹⁴ Modifying WJMY-CD's transition phase will ensure that the Station is able to continue to serve its viewers without interruption. As a result, we find the facts and circumstances discussed above outweigh any viewer burden caused by an increase in the number of rescan periods in the Montgomery DMA or temporary reduction in coverage.

We remind TTI that pursuant to the Spectrum Act, the Station is eligible for reimbursement from the TV Broadcast Relocation Fund (Fund) of costs "reasonably incurred . . . in order for the licensee to relocate its television service from one channel to the other."¹⁵ Additional expenses incurred such as expenses resulting from changes in a Station's transition plan that are not related to the post-incentive auction channel change, may not be reimbursable from the Fund.

Accordingly, we **GRANT** TTI's *Request for Modification and Waiver of Phase Assignment* and modify the transition phase assignment for WJMY-CD from Phase 5 to Phase 6, subject to all the commitments made in its waiver request and compliance with all Commission rules applicable to transitioning stations.¹⁶ Furthermore, WJMY-CD IS **REQUIRED** to air, at minimum, double the amount of consumer education notifications required by section 73.3700(c)(3) as set forth above.¹⁷ TTI is also required to further reduce power and **IMMEDIATELY MODIFY** the operational parameters in its STA should its pre-auction operation cause temporary pairwise interference to WAKA above two percent. Testing on the Station's post-auction channel **may not begin until 12:01 am local time on September 7, 2019**, and WJMY-CD is required to cease operating on its pre-auction channel **no later than 11:59 pm**

local time on October 18, 2019.¹⁸ The Station's construction permit expiration date will also be modified to correspond to its new phase completion date.¹⁹

¹⁸ Each transition phase has a designated testing period on which a station in that phase may begin testing equipment on its new channel and a designated phase completion date when a station must cease operation on its pre-auction channel. The phase completion date is the date that will be listed in that station's construction permit as its construction deadline and is the date the station must cease operation on its pre-auction channel. A station that commences testing on its postauction channel before the beginning of its assigned testing period will be operating in violation of Commission rules.
