Pursuant to these rules, consummation of the assignment consented to herein will not extend the expiration date of the permit. The construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration.

The assignee is not authorized to construct nor operate said station(s) unless and until the Commission has been notified of consummation.
