#### **Obstruction Marking and Lighting Specifications for Antenna Structure**

It is expressly understood that the issuance of these specifications is in no way to be considered as precluding additional or modified marking or lighting as may hereafter be required under the provisions of Section 303 (q) of the Communications Act of 1934, as amended.

#### **Special Operating Conditions or Restrictions**

The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

- Upon commencement of program tests in accordance with Section 73.1620 with the facilities specified herein, the licensee must cease use of the auxiliary facility authorized by license BXLH-19890330KC and request cancellation of the license since it no longer specifies auxiliary operation on the KXRS main channel. Alternatively, the licensee may seek modification of the auxiliary license to specify operation on the modified KXRS main channel. Documentation of compliance with this condition must be submitted with the FCC 302, Application for License.
- Pursuant to the grant of this construction permit and the authority found in Sections 4(i), 5(c)(1), 303 and 307 (b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b), 0.283, 1.420, 73.203(b), and 73.3573 of the Commission's Rules, the FM assignment IS MODIFIED as follows: Community, Channel No.: Add: Beaumont, CA, Channel 288A; Delete: Hemet, CA, Channel 288A. Pursuant to Section 316(a) of the Communications Act of 1934, as amended, license BLH-19881116KE IS MODIFIED to specify operation in Beaumont, CA on Channel 288A in lieu of Hemet, CA on Channel 288A.
- Permittee has specified use of the antenna listed below to demonstrate compliance with the FCC radiofrequency electromagnetic field exposure guidelines. If any other type or size of antenna is to be used with the facilities authorized herein, THE AUTOMATIC PROGRAM TEST PROVISIONS OF 47 C.F.R. SECTION 73.1620 WILL NOT APPLY. In this case, a FORMAL REQUEST FOR PROGRAM TEST AUTHORITY must be filed in conjunction with FCC Form 302-FM, application for license, BEFORE program tests will be authorized. The request must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines. EPA Type 3: Opposed "U" dipole, three sections, 0.75 wavelength spaced

Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules(See Section 83.875).

Pursuant to Section 73.3598, this Construction Permit will be subject to automatic forfeiture unless construction is complete and application for license is filed prior to expiration.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.
