If any other type or size of antenna is to be used with the facilities authorized herein, THE AUTOMATIC PROGRAM TEST PROVISIONS OF 47 C.F.R. SECTION 73.1620 WILL NOT APPLY. In this case, a FORMAL REQUEST FOR PROGRAM TEST AUTHORITY must be filed with the FCC application for license BEFORE program tests will be authorized. This request must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines.
- Pursuant to the grant of this construction permit and the authority found in Sections 4(i), 5(c)(1), 303 and 307 (b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b), 0.283, 1.420, 73.203(b), and 73.3573 of the Commission's Rules, the FM assignment IS MODIFIED as follows: Add Channel 241C3, North Corbin, KY; Delete Channel 241C3, Barbourville, KY. Pursuant to Section 316(a) of the Communication Act of 1934, as amended, License BMLH-20190508AAW IS MODIFIED to specify operation on Channel 241C3, North Corbin, KY in lieu of Channel 241C3, Barbourville, KY.

Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules(See Section 73.875).

Pursuant to Section 73.3598, this Construction Permit will be subject to automatic forfeiture unless construction is complete and application for license is filed prior to expiration.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.
