It is expressly understood that the issuance of these specifications is in no way to be considered as precluding additional or modified marking or lighting as may hereafter be required under the provisions of Section 303 (q) of the Communications Act of 1934, as amended.



## **Special Operating Conditions or Restrictions**

The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

- Notwithstanding the grant of this license or the expiration date specified herein, the license for station KXKR (FM) (Facility ID No. 2185) will expire as a matter of law if the station does not resume broadcasting operations by 12:01 a.m. on March 20, 2022. See Pub. Law No. 104-104, 110 Stat. 56, Sec 403(1) (1996).
- Upon commencement of program tests in accordance with 47 C.F.R. § 73.1620, the licensee must cease use of the auxiliary facility authorized by BXLH-20180914ABD due to a violation of 47 C.F.R. § 73.1675(a)(1). Alternatively, the licensee may seek modification of the auxiliary facility in accordance with § 73.1675(c)(1) to bring it into compliance with § 73.1675(a)(1). Documentation of compliance with this condition must be submitted with the application for license.
- BEFORE PROGRAM TESTS ARE AUTHORIZED, the permittee must submit the results of a complete proof-of-performance to establish the horizontal plane radiation patterns for both the horizontally and vertically polarized radiation components. This proof-of-performance may be accomplished using the complete full size antenna, or individual bays therefrom, mounted on a supporting structure of identical dimensions and configuration as the proposed structure, including all braces, ladders, conduits, coaxial lines, and other appurtenances; or using a carefully manufactured scale model of the entire antenna, or individual bays therefrom, mounted on the proposed supporting structure, including all appurtenances. Engineering exhibits must include a description of the antenna testing facilities and equipment employed, including appropriate photographs or sketches and a description of the testing procedures, including scale factor, measurements frequency, and equipment calibration.
- BEFORE PROGRAM TESTS ARE AUTHORIZED, the permittee must submit a certification executed by a
  licensed surveyor showing that the FM directional antenna system has been oriented at the azimuth(s)
  specified in the directional antenna proof of performance. This certification must include a description of the
  method used by the surveyor to determine the azimuth(s) of the installed directional antenna system and the
  accuracy of that determination.
- BEFORE PROGRAM TESTS ARE AUTHORIZED, the permittee must submit an affidavit that the installation of the directional antenna system was overseen by a qualified engineer. This affidavit must include a certification by the engineer that the antenna was installed pursuant to the manufacturer's instructions and list the qualifications of the certifying engineer.
- BEFORE PROGRAM TESTS ARE AUTHORIZED, the permittee must submit an exhibit demonstrating that the measured directional antenna pattern complies with the appropriate community coverage requirements of 47 C.F.R. Sections 73.315 or 73.515 (See 47 C.F.R. § 73.316(c)(2)(ix)(B)).
- The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by this construction permit. A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power: 11.5 kilowatts. Principal minima and their associated field strength limits: 210 to 230 degrees True (clockwise): 0.145 kilowatt
- Permittee has specified use of the antenna listed below to demonstrate compliance with the FCC radiofrequency electromagnetic field exposure guidelines. If any other type or size of antenna is to be used with the facilities authorized herein, THE AUTOMATIC PROGRAM TEST PROVISIONS OF 47 C.F.R. SECTION 73.1620 WILL NOT APPLY. In this case, a FORMAL REQUEST FOR PROGRAM TEST AUTHORITY must be filed in conjunction with the application for FM license BEFORE program tests will be authorized. The request must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines. Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules (See Section 83.875).

Pursuant to Section 73.3598, this Construction Permit will be subject to automatic forfeiture unless construction is complete and application for license is filed prior to expiration.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.
