- The license expiration date provided herein is tolled pursuant to 47 U.S.C. §307(C)(3) pending a final decision on the stations license renewal application. Furthermore, this license is subject to any action taken by the Commission on the renewal application.
- Grant of this license is conditioned on the licensee filing an ATSC 3.0 minor modification application within 10 days.

Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described.
