Dear Ms. LeClair:

This is in reference to the request filed on October 3, 2023. BBC requests an extension of the STA granted on March 1, 2023, as modified to operate with the licensed daytime pattern during the daytime hours, and the licensed daytime pattern reduced to 0.9 kW during nighttime hours to allow time to complete all required repairs due to flood damage.¹ In support of the request, BBC said that additional time will be needed to complete all remaining repairs and restore nighttime licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of the STA is hereby GRANTED, and BBC may now operate with the licensed DA daytime 50 kW pattern during daytime hours, and with the licensed DA daytime pattern at night with the nominal power reduced to 0.9 kW. BBC must reduce power at night or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. BBC must file a Restoration of Licensed Operation notice in LMS to certify the date the station was able to resume licensed operations per BL-19890424AI with negligible changes to verify a direct measurement of power

application is not needed.

This authority expires on **April 11, 2024.** ²

These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.
