Dear Mr. Do:

This is in reference to the request filed on September 22, 2023. Intelli requests a further extension of the STA granted on April 20, 2021, to continue operating from an alternate site with a temporary antenna to allow time to file the required minor change application (301-AM) in LMS to propose a new permanent facility (due to loss of the licensed site in 2020).¹ In support of the request, Intelli said that it is attempting to negotiate a duplexing agreement with another existing station in order to move forward and then file the application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is hereby GRANTED, and Intelli may continue to operate with the following facilities:


