Dear Ms. Torrado:

This is in reference to the request filed on March 21, 2024, as amended on April 4, 2024. JVC requests a further extension of the STA granted on January 30, 2018, to continue operating ND at night with reduced power to allow time to file the required 302-AM application in LMS to update all operating parameters.¹ In support of the request, JVC stated that additional time will be needed to complete the extensive repairs and then file the application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


We note that the previous STA expired on December 26, 2023, and therefore the authority granted herein does not cover the period between that date and the filing date of this STA extension request, and is without prejudice as to whatever action the Commission may take with respect to operation of Station WPRD during the foregoing period.

¹ WPRD(AM) is licensed for operation on 1440 kHz with 5 kW day (ND) and 1 kW night (DA).

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and JVC may continue to operate ND at night with 0.25 kW, with no change to the licensed daytime 5 kW operation. JVC must reduce the nighttime power level or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **October 12, 2024.** ²

²Periods of operation pursuant to this STA shall be recorded in the station's records (see 47 CFR § 73.1820). The records shall include start/stop dates and times of such operation. These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.
