 from such stations.
- This authorization is conditioned that the station will not begin transmitting on the requested channel 32 prior
 to discontinuation of operation by station: Call Sign WRLK-TV that is currently licensed to use channel 32 and
 Call Sign: WEBA-TV that is currently licensed to use adjacent channel 33

Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described.
