- This authorization is subject to the condition that low power television is a secondary service, and that low power television and television translator stations must not cause interference to the reception of existing or future full service television stations on either allotted NTSC or DTV channels, and must accept interference from such stations.
- This authorization is conditioned that the station will not begin transmitting on the requested channel 22 prior to discontinuation of operation by station: Call Sign WHNS that is currently licensed to use adjacent channel 21. ---- and ---- This authorization is conditioned that the station will not begin transmitting on the requested channel 22 prior to discontinuation of operation by station: Call Sign: WCNC-TV that is currently licensed to use channel 22.

Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.
