> Re: Request for Tolling Waiver KGBT-TV, Harlingen, TX Facility ID No. 34457 LMS File No. 0000124992

Dear Licensee,

On October 23, 2020, KGBT Licensee, LLC (Sinclair), the licensee of Station KGBT-TV, Harlingen, Texas (KGBT or Station), filed the above-referenced request for waiver of the Commission's tolling provisions and tolling of the Station's construction permit. For the reasons below, we grant Sinclair's waiver request and toll KGBT's construction permit through December 30, 2020.

Background. Pursuant to section 73.3700(b)(5) of the Commission's rules (Rules), a station that was assigned a new channel as a result of the Commission's incentive auction and repacking process may request a single extension of its construction permit deadline of up to 180 days to complete construction of its post-auction facility.¹ All subsequent requests for additional time to construct are subject to the Commission's tolling provisions of section 73.3598(b) of the Rules.² The Commission's tolling provisions provide that a construction permit deadline may be tolled under specific circumstances such as acts of God, delays due to administrative or judicial review, or construction that is delayed by any cause of action pending before a court of competent jurisdiction relating to any necessary local, state, or federal requirement for the construction or operation of the station, including any zoning or environmental requirement.³ If a station does not qualify for tolling under these criteria, good cause may exist to waive the Commission's tolling provisions and tolling may still be warranted where the licensee can demonstrate that "rare and exceptional circumstances" prevented construction by the station's construction permit expiration date.⁴

Sinclair requests waiver of the tolling rule and tolling of its construction permit for its postincentive auction channel facilities through December 30, 2020. KGBT is currently operating on its post-

auction channel using an interim facility while it completes construction of its post-auction channel facilities.⁵ KGBT was previously granted a construction permit extension through October 31, 2020.⁶

Sinclair states that the Station has made significant progress in constructing its post-auction channel facilities, including installation of its transmitter. However, installation of the Station's post-auction channel antenna was delayed due to scheduling and tower crew issues brought on by the global COVID-19 pandemic. More recently additional delays have resulted from the lack of availability of helicopters to perform the top mount antenna installation due to the deployment of helicopters to fight wildfires in California. Therefore, in light of these circumstances, Sinclair requests tolling of the Station's construction permit through December 30, 2020.

Discussion. Upon review of the facts and circumstances presented, we find that sufficient circumstances exist to waive the rules and toll the expiration date of the Station's construction permit through December 30, 2020.⁷ Sinclair has demonstrated it did not complete construction of its post-auction channel facilities due to construction delays. We also find that grant of Sinclair's tolling request is not likely to negatively impact the overall transition schedule and will not cause interference to other stations. KGBT has already ceased operation on its pre-auction channel and initiated temporary operations on its post-auction channel. To the extent some viewers are unable to receive KGBT's signal while it operates using its interim facility, we believe that Sinclair has every incentive to ensure viewers are fully informed about the Station's transition plan. Ultimately, we conclude that the public interest will be served by grant of tolling of the Station's construction permit.

We remind Sinclair that pursuant to the Spectrum Act, the Station is eligible for reimbursement from the TV Broadcast Relocation Fund (Fund) of costs "reasonably incurred . . . in order for the licensee to relocate its television service from one channel to the other."⁸ Additional expenses incurred, such as expenses resulting from changes in a Station's transition plan that are not related to the post-incentive auction channel change, may not be reimbursable from the Fund.

We further remind Sinclair of the deadline for submitting final expense documentation for reimbursement for the Station is March 22, 2022.⁹ Thus, we strongly encourage the Station to diligently pursue satisfaction of the current deadlines to improve the chances that there will be sufficient funds available to reimburse the Station for its legitimate repacking expenses, and we encourage Sinclair to submit eligible invoices as soon as practicable.

The above facts considered, KGBT Licensee, LLC's request for waiver of the Commission's tolling provisions **IS GRANTED**. The construction permit (LMS File No. 0000105747) for KGBT-TV, Harlingen, Texas, **IS TOLLED to December 30, 2020**. Grant of this tolling waiver does not permit KGBT to recommence operation on its pre-auction channel. We also remind Sinclair that any subsequent requests for tolling of its construction permit deadline will be subject to the Commission's tolling provisions.¹⁰
