Special Operating Conditions or Restrictions

The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

- The station is utilizing a shared antenna for this auxiliary facility. Only one station will use this facility at a time.
- The licensee has demonstrated compliance with the FCC radiofrequency electromagnetic field exposure
 guidelines based upon the usage of the antenna specified herein. If the licensee makes any changes in
 facilities via modification of license application in accordance with 47 CFR section 73.1690(c), the subsequent
 application for license must include a revised RF field showing to demonstrate continued compliance with the
 FCC guidelines.
- The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by Construction Permit File No. BXPH-20190719AAM. A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power: 2.5 kilowatts. Principal minima and their associated field strength limits: 130 degrees True: 0.013 kilowatt

Subject to the provisions of the Communications Act of 1934, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this license, the licensee is hereby authorized to use and operate the radio transmitting apparatus herein described.

Neither the license nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This license is subject to the right of use or control by the Government of the United States conferred by Section 606 of the Communications Act of 1934.
