Request for Extension of Special  
Temporary Authority to Remain Silent

Dear Mr. Turvaville:

This letter concerns the request you filed on June 23, 2023, on behalf of Great Plains Christian Radio, Inc. (GPCR), for extension of Special Temporary Authority (STA) to permit FM Translator Station K210BQ to remain silent.

Commission records reflect that GPCR stated that Station K210BQ went silent on December 16, 2022, because it lost its programming source. The previous STA was granted on January 5, 2023, and expires on July 4, 2023. GPCR requests extension of its STA while it continues searching for a new programming source.

GPCR's request is granted. Accordingly, Special Temporary Authority is granted to permit Station K210BQ to remain silent until December 16, 2023. **Notwithstanding the grant of this Special Temporary Authority, the broadcast license for Station K210BQ will automatically expire as a matter of law if broadcast operations do not resume by 12:01 a.m., December 17, 2023.**<sup>1</sup>

GPCR is required to notify the Commission when broadcast operations resume.<sup>2</sup> If GPCR does not file the notification of resumption of operations in a timely manner, the license may be subject to cancellation pursuant to section 312(g) of the Communications Act, as amended.<sup>3</sup>

The station's silent status does not suspend the licensee's obligation to comply with all other relevant Commission rules, including the filing, when appropriate, of applications for renewal of

These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.

broadcast license. It is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower shall be maintained until removed.<sup>4</sup>
