Request for Extension of Special
Temporary Authority to Remain Silent

Dear Mr. Brentlinger:

This letter concerns the request you filed on July 24, 2023, on behalf of High Plains Radio Network, LLC (HPRN), for extension of Special Temporary Authority (STA) to permit Radio Station KICA-FM to remain silent.

Commission records reflect that HPRN stated that Station KICA-FM went silent on December 31, 2022, for technical reasons. The previous STA was granted on January 9, 2023, and expired on July 8, 2023.¹ HPRN requests extension of its STA for continuing technical reasons.

HPRN's request is granted. Accordingly, Special Temporary Authority is granted to permit Station KICA-FM to remain silent until December 31, 2023. **Notwithstanding the grant of this Special Temporary Authority, the broadcast license for Station KICA-FM will automatically expire as a matter of law if broadcast operations do not resume by 12:01 a.m., January 1, 2024.**²

HPRN is required to notify the Commission when broadcast operations resume.³ If HPRN does not file the notification of resumption of operations in a timely manner, the license may be subject to cancellation pursuant to section 312(g) of the Communications Act, as amended.⁴

The station's silent status does not suspend the licensee's obligation to comply with all other relevant Commission rules, including the filing, when appropriate, of applications for renewal of

The action taken herein shall not be construed as authorizing the station to remain silent between July 8, 2023, and July 24, 2023. See 47 C.F.R. § 73.1740(a)(4).

³ In addition, periods of operation pursuant to this STA shall be recorded in the station's records (see 47 CFR §§ 73.1820 (AM/FM/TV), 73.877 (LPFM) and/or 74.1281 (FM translator)). The records shall include start/stop dates and times of such operation. These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.

broadcast license. It is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower shall be maintained until removed.⁵
