<p>Special Operating Conditions or Restrictions</p> <p>The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.</p> <ul style="list-style-type: none"> • Prior to commencing program test operations, FM Translator or FM Booster permittee must have on file an Application for an FM Translator or FM Booster Station License, pursuant to 47 C.F.R. Section 74.14. • Pursuant to the waiver of 47 CFR Section 74.1233(a)(1) granted herein the permittee/licensee shall be subject to a holding period. The permittee/licensee may NOT change the AM primary station listed on this authorization. Once a license application is filed to cover this construction permit, this facility is required to rebroadcast this AM primary station for four years. Periods of station silence shall not count toward the fulfillment of this four-year requirement. During this same four year period the permittee/licensee may not assign or transfer the construction permit/license to another party, unless it is to the licensee of the AM station being rebroadcast. Minor modifications of this authorization are permitted, provided the translator will continue to rebroadcast the AM station for which the waiver was granted.

Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules(See Section 83.875).

Pursuant to Section 73.3598, this Construction Permit will be subject to automatic forfeiture unless construction is complete and application for license is filed prior to expiration.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.
