- Commission records reflect that stations K209CF; Fac. ID: 81118, W209CL; Fac. ID: 83669 and K208CK; Fac. ID: 81603 have been off the air since July 19, 2023, June 26, 2023 and July 22, 2023 respectively. Therefore, the licenses for these stations will expire as a matter of law if the stations do not resume broadcast operations by July 20, 2024; June 27, 2024 and July 23, 2024 , 12:01AM, respectively. See Pub. Law No. 104-104, 110 Stat. 56, Sec. 403(l), codified at 47 U.S.C. Section 312(g).

Under authority of the Communications Act of 1934, as amended, the consent of the Federal Communications Commission is hereby granted to the transaction indicated above.

The Commission's consent to the above is based on the representations made by the applicants that the statements contained in, or made in connection with, the application are true and that the undertakings of the parties upon which this transaction is authorized will be carried out in good faith.

The assignee is not authorized to construct nor operate said station(s) unless and until the Commission has been notified of consummation.
