Dear Mr. Witkovski:

This is in reference to the request filed on October 30, 2023. NTRG requests a further extension of the STA granted on December 6, 2022, as last modified on May 4, 2023, to continue operating from an alternate site location to allow time to file the required minor change application (301-AM) in LMS due to the sale of the old licensed site.¹ In support of the request, NTRG stated that additional time will be needed to secure a new suitable site and then file the application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and NTRG may continue to operate with the following facilities:



This Special Temporary Authority does not supersede any non-FCC-regulated requirements applicable to the STA-authorized facility. The licensee remains solely and wholly responsible for maintaining compliance with such requirements. NTRG must reduce power or cease operation if complaints of interference are received, and must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on **May 5, 2024**.²

²Periods of operation pursuant to this STA shall be recorded in the station's records (see 47 CFR § 73.1820). The records shall include start/stop dates and times of such operation. These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.
