Request for Extension of Special
Temporary Authority to Remain Silent

Dear Mr. Snavelly:

This letter concerns the request you filed on November 7, 2023, on behalf of Family Life Ministries, Inc. (FLM), for extension of Special Temporary Authority (STA) to permit Radio Station WGCC-FM to remain silent.

Commission records reflect that FLM stated that Station WGCC-FM went silent on April 29, 2023. The previous STA was granted on May 12, 2023, and expired on November 11, 2023. FLM requests extension of its STA for continuing technical reasons.

FLM's request is granted. Accordingly, Special Temporary Authority is granted to permit Station WGCC-FM to remain silent until April 29, 2024. **Notwithstanding the grant of this Special Temporary Authority, the broadcast license for Station WGCC-FM will automatically expire as a matter of law if broadcast operations do not resume by 12:01 a.m., April 30, 2024.**¹

FLM is required to notify the Commission when broadcast operations resume.² If FLM does not file the notification of resumption of operations in a timely manner, the license may be subject to cancellation pursuant to section 312(g) of the Communications Act, as amended.³

The station's silent status does not suspend the licensee's obligation to comply with all other relevant Commission rules, including the filing, when appropriate, of applications for renewal of

The records shall include start/stop dates and times of such operation. These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.

broadcast license. It is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower shall be maintained until removed.⁴
