Special Operating Conditions or Restrictions

The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

- The relative field strength of the measured vertically polarized radiation component shall not exceed at any azimuth the value indicated on the composite radiation pattern authorized by Construction Permit BPED-19860307MK. A relative field strength of 1.0 on the composite radiation pattern authorized by Construction Permit BPED-19860307MK corresponds to the following effective radiated power: 6.3 kilowatts Principal minima and their associated field strength limits: 200 to 230 degrees True: 0.2 kilowatt

This license is subject to the right of use or control by the Government of the United States conferred by Section 606 of the Communications Act of 1934.
