Pursuant to the 1999 ShareTime Agreement between The Regents of the University of Minnesota ("University") and the Independent School District #283 (District 283"), as amended, University shall operate from 4:30 PM to 8:00 AM and District 283 shall operate from 8:00 AM to 4:30 PM on Designated School Days. On all other days, including weekends, holidays, and District 283 school vacations, University shall be authorized unlimited operatrion.
