2 Warning signs which describe the radiofrequency radiation hazard must be posted at least 14 meters from the base of the tower and at appropriate intervals. The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized in construction permit BMPED-931202IA.
