- BEFORE PROGRAM TESTS COMMENCE, sufficient measurements must be made to establish that the operation authorized in this construction permit is in compliance with the spurious emissions requirements of 47 C.F.R. Sections 73.317(b) through 73.317(d). All measurements must be made with all stations simultaneously utilizing the shared antenna. These measurements must be submitted to the Commission with the FCC Form 302-FM, application for license.

Special operating conditions or restrictions:

The permittee has specified the use of a ten (10) section, 0.75 wavelength spaced antenna to demonstrate compliance with the FCC radiofrequency electromagnetic field exposure guidelines. If any other type or size of antenna is to be used with the facilities authorized herein, THE AUTOMATIC PROGRAM TEST PROVISIONS OF 47 C.F.R. SECTION 73.1620 WILL NOT APPLY. In this case, a FORMAL REQUEST FOR PROGRAM TEST AUTHORITY must be filed with the FCC Form 302-FM, application for license, BEFORE program tests will be authorized. This request must include a revised RF field showing to demonstrate continued compliance with the FCC quidelines.

5 FAA INTERFERENCE CONDITION:

Upon receipt of notification from the Commission that harmful interference is being caused by the operation of the permittee's/licensee's transmitter, the permittee/licensee must either immediately reduce the power to the point of no interference, cease operation, or take such immediate corrective action as is necessary to eliminate the harmful interference. This condition expires after one year of interference-free operation.
