2 Location of Monitor Points:

Direction of 13.5° true North. The monitoring point is located on Hamilton Circle, in front of house number 49004 on north shoulder near walkway at pavement edge. NAD 27 Coordinates: N35°18'11.8" W80°51'09.7".

Direction of 310.5° true North. The monitoring point is located on Cora Street, at intersection of Byrum Street on north shoulder at pavement edge. NAD27 Coordinates: N35°17'57.9" W80°53'52.8".

3 Ground System:

Ground system consists of 120 equally spaced, buried copper radials about the base of each tower, extending up to 86.2 meters around the south tower except where they intersect the existing bisector strap or property line and extending up to 86.2 meters to the east on the north tower to south tower radials but otherwise 48.8 meters in length except where intersecting radials are shortened and bonded to a transverse copper strap midway between adjacent towers.

4 Licensee shall be responsible for satisfying all reasonable complaints of blanketing interference within the 1 V/m contour as required by Section 73.88 of the Commission's rules.
