Special operating conditions or restrictions:

- 3 The Board of Education of the City of Albuquerque, NM was granted a waiver of 47. C.F.R. Section 73.1125 to operate the proposed facility as "satellite" of co-owned noncommercial educational FM station KDRI(FM), Grants, New Mexico, (Facility ID No.: 83874). Based upon the specific representations contained therein, the waiver request IS GRANTED. Applicant shall abide by each representation proffered in the waiver request.
