If consummation does not occur prior to June 1, 2013, the transaction may not be consummated until after the license for the station has been renewed.

Commission records reflect that station K228DA; Fac. ID No.18541 has been off the air since June 30, 2012. Therefore, the license for this station will expire as a matter of law if the station does not resume broadcast operations by June 30, 2013, 12:01AM. See Pub. Law No. 104-104, 110 Stat. 56, Sec. 403(l), codified at 47 U.S.C. Section 312(g)

Under authority of the Communications Act of 1934, as amended, the consent of the Federal Communications Commission is hereby granted to the transaction indicated above.
