BEFORE PROGRAM TEST AUTHORITY is authorized by the Commission a fence must be erected at such distances (at least 4.0 meters from the base of the tower) and in such a manner as to prevent the exposure of humans to radiofrequency radiation in excess of the American National Standards Institute Guidelines (OST Bulletin No. 65, October 1985). The fence must be of a type which will preclude casual or inadvertent access, and must include warning signs at appropriate intervals which describe the nature of the hazard. Permittee shall submit documentation of compliance with this special operating condition along with the Form 302, application for license, and the request for program test authority.

During installation of the antenna authorized herein, AM Station(s) listed below shall determine operating power by the indirect method. Upon completion of the installation, antenna impedance measurements on the AM antenna shall be made and, prior to or simultaneous with the filing of the application for license to cover this permit, the results submitted to the Commission (along with a tower sketch of the installation) in an application for the AM Station to return to the direct method of power determination.
