Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. - 2 Ground system consists of 120 equally spaced, buried, copper radials , extending 51.8 meters in length, about the base of each tower in addition to 120 shorter radials extending 15.2 meters interspersed between the long radials.
