Licensee is using a Eight section, ½ wavelength spaced ERI MPX-8C-HW, antenna to comply with the FCC radiofrequency electromagnetic field exposure guidelines. Use of any other type or size antenna will require a revised RF field showing to demonstrate continued compliance with FCC guidelines.
