The failure of the facility to so operate will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(e) unless the licensee rebuts presumption that the authorized facilities were temporarily constructed.

Special operating conditions or restrictions:

- 3 The permittee/licensee, in coordination with other users of the site, must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of the FCC guidelines.

- 4 The licensee has demonstrated compliance with the FCC radiofrequency electromagnetic field exposure guidelines based on the use of the antenna specified herein. If the licensee makes any changes in the facilities via a modification of license application in accordance with 47 C.F.R. Section 73.1690(c), the subsequent FCC Form 302-FM, application for license, must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines.

- 5 The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by Construction Permit BPH-20131220HHF.

A relative field strength of 1.0 on the composite radiation pattern authorized by Construction Permit BPH-20131220HHF corresponds to the following effective radiated power:

9.5 kilowatts
