Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.

Special operating conditions or restrictions:

Calvary Chapel of Twin Falls, Inc. was granted a waiver of 47 C.F.R. § 73.1125 to allow the operation of this station as a "satellite" operation of co-owned noncommercial educational FM Station KLWD(FM), Gillette, Wyoming (Facility ID No.: 84184). See License File No. BLED-20051212ACJ, granted December 20, 2005). This waiver is continued. Calvary Chapel of Twin Falls, Inc. shall abide by each representation proffered in the waiver request.

Special operating conditions or restrictions:

- The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- Further modification to the facilities of Station KOHR(FM), Sheridan, Wyoming (Facility ID No.: 89342) and the construction permit (File No. BPED-19980810MD) for Station KVLZ(FM), Sheridan, Wyoming (Facility ID No.: 91354) will not be construed as a per se modification of KWCF's authorization.
