Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.

BEFORE PROGRAM TEST AUTHORITY IS AUTHORIZED BY THE 1 COMMISSION, THE PERMITTEE SHALL MAKE PROPER RF FIELD STRENGTH MEASUREMENTS ATOP THE ROOF OF THE PRUDENTIAL TOWER BUILDING TO DETERMINE IF THERE ARE ANY AREAS THAT EXCEED THE ANSI, EPA, AND FCC SPECIFIED GUIDELINES FOR HUMAN EXPOSURE TO RADIOFREQUENCY RADIATION. THESE MEASUREMENTS SHALL BE MADE DURING THE EQUIPMENT TEST PERIOD AND PRIOR TO THE COMMENCEMENT OF PROGRAM TEST OPERATIONS, AND THE RESULTS THEREOF SUBMITTED WITH THE FCC FORM 302 FOR LICENSE. ANY AREAS FOUND TO EXCEED THE RECOMMENDED GUIDELINES MUST BE POSTED WITH WARNING SIGNS THAT DESCRIBE THE NATURE OF THE HAZARD, AND ACCESS MUST BE RESTRICTED SO AS TO PRECLUDE CASUAL OR INADVERTENT ENTRY INTO SUCH AREAS. MEASURES SHALL BE IMPLEMENTED SO AS TO PREVENT WORKERS ON THE ROOF OR TOWER FROM ACCIDENTAL EXPOSURE.

BEFORE PROGRAM TEST COMMENCE, SUFFICIENT MEASUREMENTS SHALL BE MADE TO ESTABLISH THAT THE OPERATION AUTHORIZED IN THIS CONSTRUCTION PERMIT IS IN COMPLIANCE WITH THE SPURIOUS EMISSIONS REQUIREMENTS OF SECTIONS 73.317(b) THROUGH 73.317(d) OF THE COMMISSION'S RULES. ALL MEASUREMENTS MUST BE MADE WITH STATIONS WZLX, WBCN, AND WMJX SIMULTANEOUSLY UTILIZING THE ERI TYPE NO. 1084-6CP-SP ANTENNA. THESE MEASUREMENTS SHALL BE SUBMITTED TO THE COMMISSION ALONG WITH THE FORM 302 APPLICATION FOR LICENSE.
