Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

THIS PROOF-OF-PERFORMANCE MAY BE ACCOMPLISHED USING THE COMPLETE FULL SIZE ANTENNA, OR INDIVIDUAL BAYS THEREFROM, MOUNTED ON A SUPPORTING STRUCTURE OF IDENTICAL DIMENSIONS AND CONFIGURATION AS THE PROPOSED STRUCTURE, INCLUDING ALL BRACES, LADDERS, CONDUITS, COAXIAL LINES, AND OTHER APPURTENANCES; OR USING A CAREFULLY MANUFACTURED SCALE MODEL OF THE ENTIRE ANTENNA, OR INDIVIDUAL BAYS THEREFROM, MOUNTED ON AN EQUALLY SCALED MODEL OF THE PROPOSED SUPPORTING STRUCTURE, INCLUDING ALL APPURTENANCES. ENGINEERING EXHIBITS SHOULD INCLUDE A DISCRIPTION OF THE ANTENNA TESTING FACILITIES AND EQUIPMENT EMPLOYED, INCLUDING APPROPRIATE PHOTOGRAPHS OR SKETCHES AND A DESCRIPTION OF THE TESTING PROCEDURES, INCLUDING SCALE FACTOR, MEASUREMENTS FREQUENCY, AND EQUIPMENT CALIBRATION.

THE RELATIVE FIELD STRENGTH OF NEITHER THE MEASURED HORZ. NOR VERT. POLARIZED RADIATION COMPONENT SHALL EXCEED AT ANY AZIMUTH THE VALUE INDICATED ON THE COMPOSITE RADIATION PATTERN AUTHORIZED BY THIS CONSTRUCTION PERMIT.
